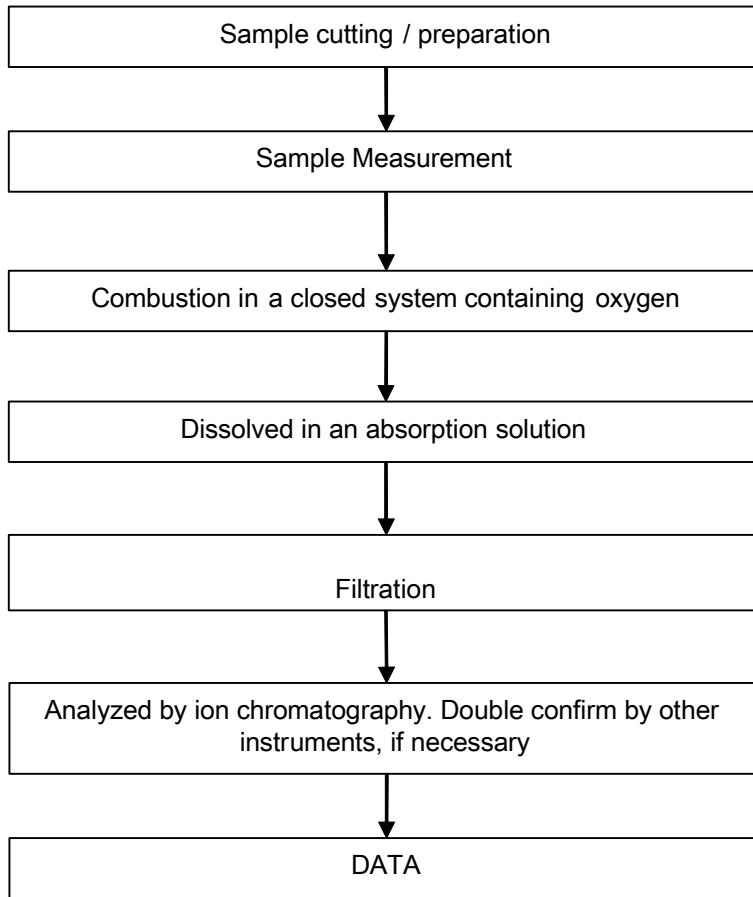

Halogen Testing Flow Chart

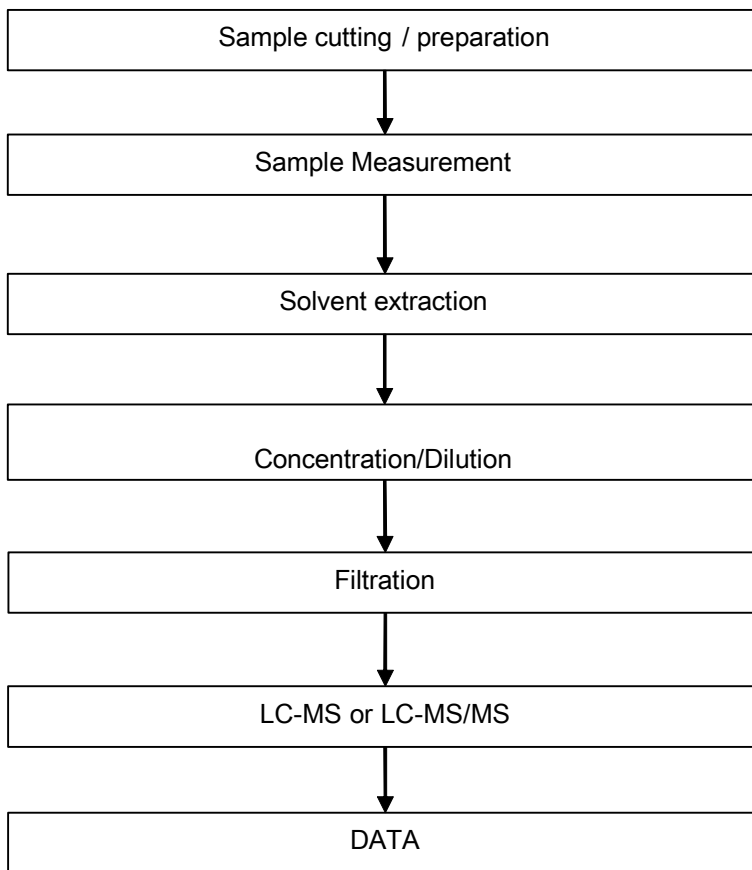

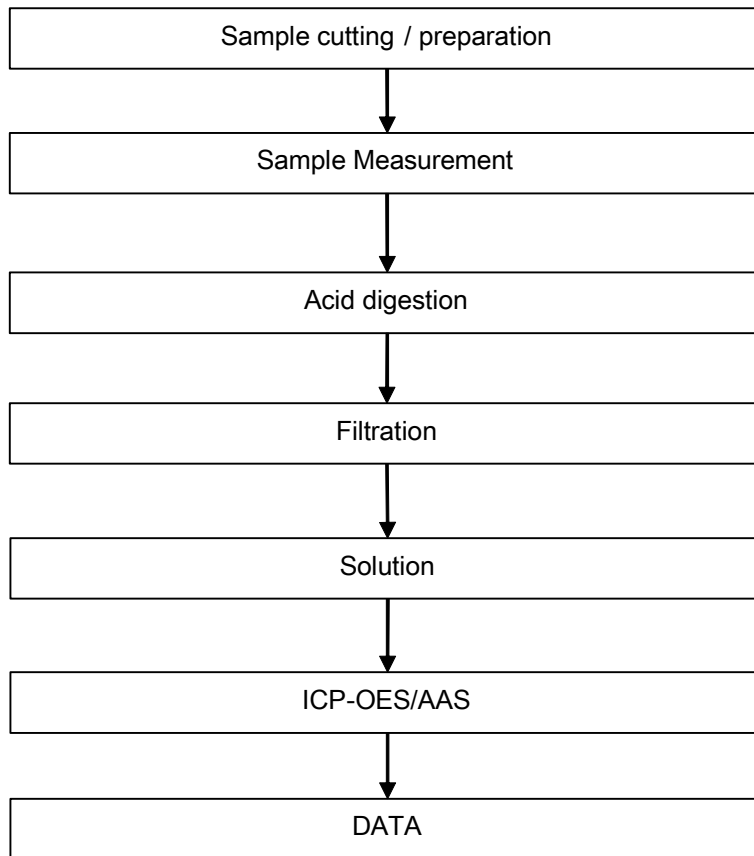

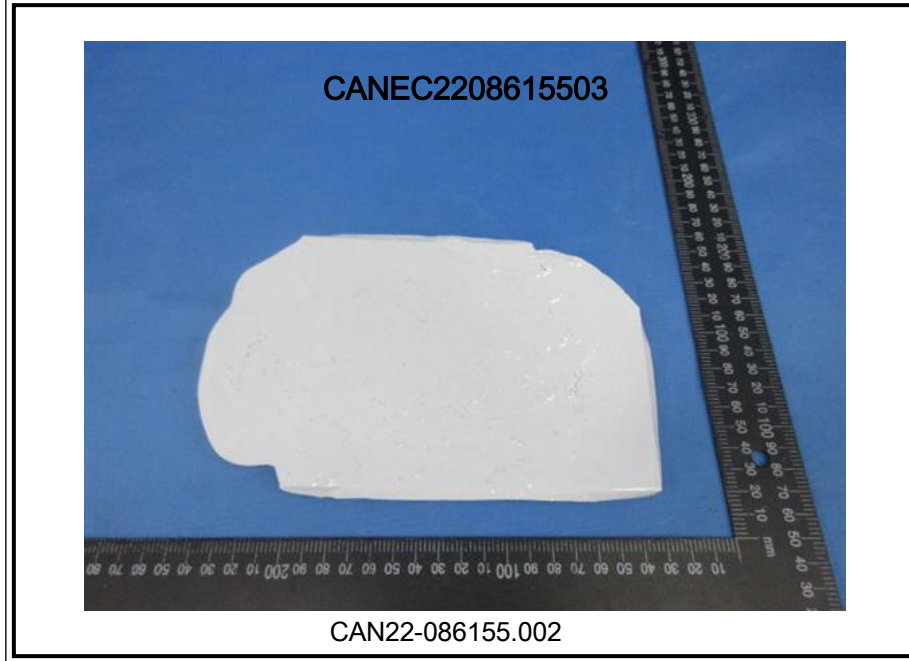
Elementary Testing Flow Chart
